


Energy rating and score

How this affects your energy bills

An average household would need to spend £1,585 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy bills.

6. Heating controls (room thermostat and TRVs)	£220 - £250	£154
7. Gas condensing boiler	£3,500 - £10,000	£92
8. Solar photovoltaic panels	£8,000 - £10,000	£212
