


# **Energy rating and score**

5. Condensing boiler	£2,200 - £3,000	£94
6. Floor insulation (solid floor)	£4,000 - £6,000	£29
7. Solar water heating	£4,000 - £6,000	£57
8. Solar photovoltaic panels	£3,500 - £5,500	£413
