YARD

The yard is accessed via a shared laneway off Knocknougher Road and comprises of modern cattle and sheep sheds, stock handling facilities and earth bank silo clamp.

The main shed is a 19 bay steel portal frame purpose built sheep shed with concrete central passageway (20 ft wide) and wire mesh slats serviced by water drinkers. Surrounding the shed there is a covered concrete apron.

The cattle shed comprises of 4 concrete slatted pens with solid floor lying in area. Externally, there's a covered race and crush with 4 pedestrian doors.

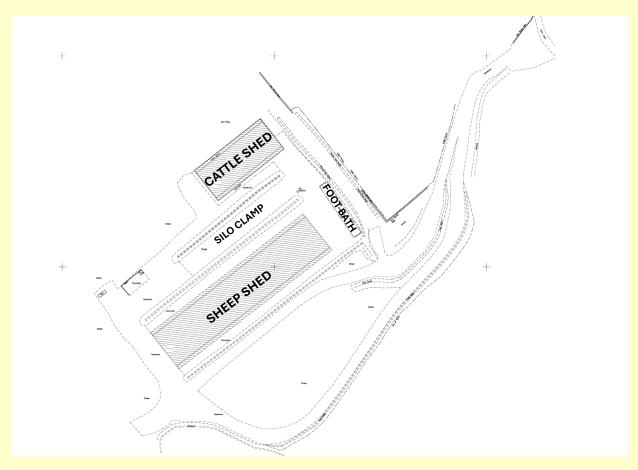
LAND

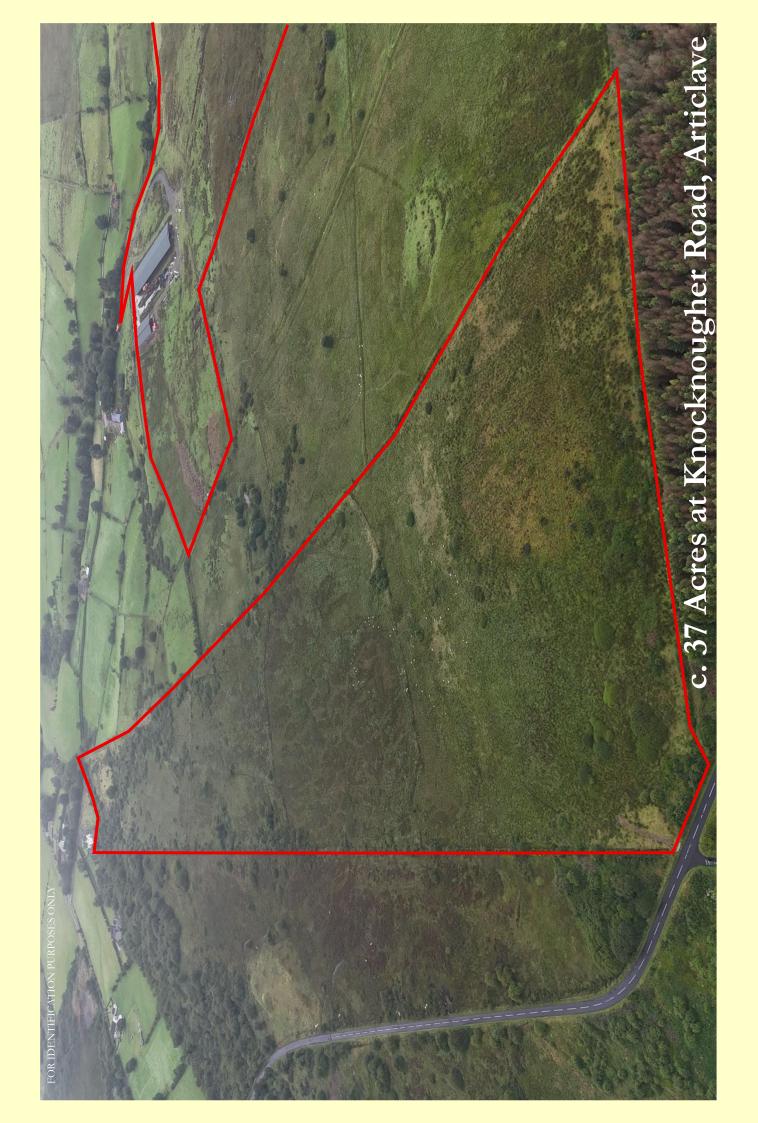




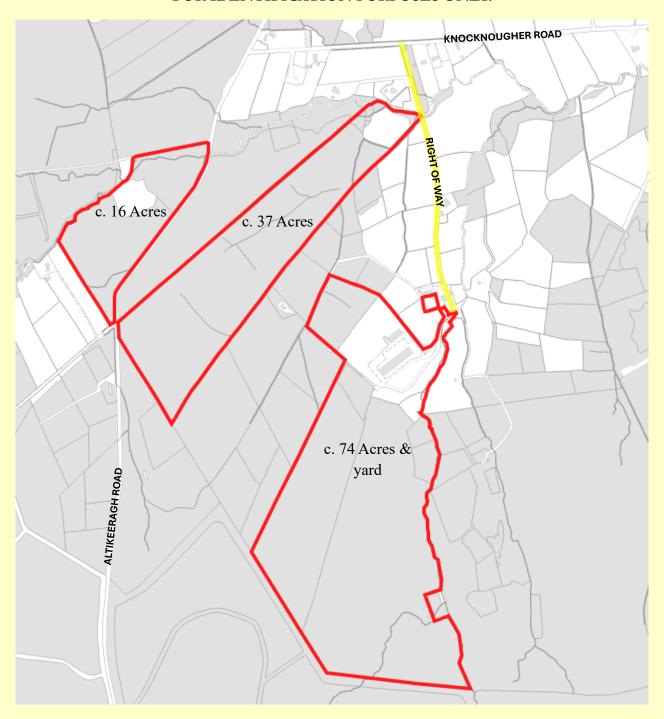
YARD LAYOUT FOR IDENTIFICATION PURPOSES ONLY NOT TO SCALE
